ANUAL REPORT DEDICATION ROBERT "BOB" LESO

This dedication is written in loving memory of Robert "Bob" Leso, a man whose life was a testament to service, dedication, and a deep love for his family, community, and the Maine woods. We lost Bob unexpectedly in a motor vehicle accident in November of 2024.

Bob's journey began in the Casco, Maine area, where he grew up and honed his athletic skills playing basketball and baseball for Casco Bay High School. His passion for the outdoors led him to the University of Southern Maine, where he played catcher for a year before transferring to the University of Maine at Orono to pursue his degree in Forestry.

A pivotal moment during his time at Orono was hearing John F. Kennedy speak about serving the country. Inspired by this call to action, Bob joined the Peace Corps after graduating from UMO, spending three years in Peru as a Spanish translator.

1967. Bob's service continued as he was drafted into the Army and sent to Vietnam, where he served for a year and was awarded the Star. Bronze Upon his honorable discharge, returned home and began working in Bangor, supervising a crew of land surveyors.

Fate intervened at the Eastern States Exposition in Massachusetts, where Bob, representing Maine in the forestry section, met Mimi, who was representing the sesquicentennial. Maine's two-year courtship culminated in marriage on September 16, 1972. They settled in Farmington, then quickly moved to beloved 80-acre property in Chesterville in 1974, where they built their life together, later adding 110 acres in New Sharon. Bob and Mimi shared 52 wonderful vears marriage.

Bob was a devoted father to his sons Andrew and John, coaching them in baseball for many years and enthusiastically attending his grandsons' games all through school. Bob loved to watch his grandsons' success on the baseball field and the basketball court.

A founding father of the Bureau of Forestry in Maine, Bob dedicated his career to preservation and management Maine's forests. He worked for the Bureau from around 1970 until his retirement at 64, after which he continued to serve private consulting Forester. His commitment to his community extended to 42 years of service on the Chesterville Planning Board, a role he held until his passing. He received an award for his seven years of coaching baseball, was instrumental in creating the baseball field at the Chesterville town office with Greg Soule, and was honored with the Outstanding Stewardship Award for his forestry management. He also served on the board for the Franklin County Soil and Water Conservation District from the time he was a young man and was still active on that board at the time of his passing. Bob was a member of the Small Woodlot Owners Association, long-time member of the Maine Tree Farm Committee, serving as a tree farm inspector and Franklin County Tree Farm Chair. He also co-hosted a weekly radio program on forestry and agriculture with Rick Barr on local radio station WKTJ-FM 99.3 for a time.

BOARD OF SELECTMEN

Greetings,

The year presented the Selectboard with numerous challenges, but we are proud of the significant accomplishments we made in 2024, and we greatly appreciate the continued support of our citizens. Town meeting took place in March with lots of great debate and the election of three new board members. We welcomed Justin Richards for a one year term, Jason Ward for a one year term, and Earl Martin Jr. for the three year term. The business portion of town meeting is currently held on a Monday evening in March. In recent years attendance has waned, so the board is including an article on the warrant to consider moving the annual meeting to a Saturday in 2026, with the hope that more people can attend.

A primary focus this year was obtaining licensing from the Department of Environmental Protection (DEP) for our transfer station. Early in the year, we learned that we were not in compliance with statutory requirements for transfer stations and landfills. Efforts are still in the works, but we've made great strides. Selectman Martin was instrumental in spearheading this endeavor from the start. He had support from Selectman Archer, and staff members Hubert Labreck, and Bob Jones, who have diligently worked toward this goal. The public works department also provided valuable support by clearing brush and preparing the transfer station site for the necessary changes. This project demonstrates the collaborative spirit that has guided our efforts.

In the spring, Pikes Paving successfully resurfaced portions of Borough Road, West and East Roads, Sand Pond Road, George Thomas Road, and Sanborn Hill Road. Our dedicated road crew has consistently maintained and prepared our roadways for future paving projects. Numerous culvert replacements and extensive ditching have been completed throughout town. Clayton Tibbetts and his team ensured all town vehicles were serviced and prepared for winter plowing operations. Christine Stevens, who serves on the Highway Committee, and Melissa Taylor, our town Clerk, have diligently pursued reimbursement claims from the Federal Emergency Management Agency (FEMA) for damages incurred during declared storms spanning two years. The Town will use the funds to offset future Capital Roads expenditures and the Public Works budget. Clayton is working with the board to identify paving priorities for 2025 based on town meeting appropriations and FEMA reimbursements.

The Recreation Committee hosted a successful opening day for Cal Ripken baseball right here at the Chesterville field! This event is usually hosted in Farmington, but the Chesterville field improvements made for the best location. Through generous donations, the committee raised over \$4,000 to purchase an equipment shed for the ballfield. We express our sincere gratitude to David Gray, Katlin Hilton, Danielle Plancon, Selectman Richards, and Selectman Hilton for their instrumental roles in acquiring and securing the shed. We also acknowledge the valuable contributions of the entire Recreation Department in fundraising and revitalizing recreational activities within our community.

On September 26th a special town meeting was held to address two critical matters: the appropriation of remaining American Rescue Plan Act (ARPA) funds, and the selection of a new town-wide trash pickup provider. Residents voted to transition from Archie's to Casella's Waste beginning January 1, 2025.

ARPA funds were fully expended by December 31st, 2024. The funds were used over a two year period. Some of the highlights were significant improvements to the fire station and town hall bathrooms, including ADA Compliance. An energy audit performed at the town office to include upgrades for efficiency in the building. Painting of the town garage, culverts and maintenance performed on public works vehicles. There were also updates to the Selectman and Treasurer's office, and a new concrete pad and Conex shipping container at the Transfer Station. We want to extend a special thanks to Selectman Richards for the work his business performed on the Fire Department bathroom, which was a substantial renovation and remodel. We also want to thank Erin and Jared Norton, Selectman Hilton, Selectman Archer, and Rob Rogers who worked on the town hall restrooms. We continue to get compliments about the improvements.

During the tax commitment processes the board was guided by our assessing agent to 'factor up' in order to certify at 100% of valuation. The goal was to avoid loss of revenues and a lower homestead exemption on taxes. Consequently, folks who had previously received the stabilization credit (now rescinded by the state) saw a large spike in taxation. Others were impacted with spikes in taxation as well because land was factored at a lower percentage than buildings. As a result the Board is actively exploring strategies to mitigate this effect on next year's and future tax commitments. To address potential inequities in property valuations, the Selectboard is investigating a town-wide re-evaluation. In the past three years, our assessor's agent has consistently recommended across-the-board percentage increases to valuation. A re-evaluation would establish a more equitable and accurate assessment of property values. You'll see an article for consideration on this year's town meeting warrant.

The Town's election crew effectively managed the highest voter turnout in recent history during the November 2024 presidential election. Chesterville demonstrated exemplary service, with the crew receiving commendation from an inspector for their thorough preparation and execution. We commend their dedication and express our gratitude for their seamless handling of this important civic duty.

The Selectboard encourages residents to engage with our state representatives, senators, and legislators to express concerns about the rising tax burden across Maine. Furthermore, the Selectboard recommends getting involved with the RSU9 school budget process. Currently, education represents a significant portion of our town's budget at 52%.

The Selectboard acknowledges and expresses its deepest gratitude to the valuable contributions of our dedicated town employees. We commend the administrative staff for their unwavering commitment and exceptional work ethic. We thank the transfer station crew for their cooperation and adaptability during the DEP licensing process and the transition to Casella. We recognize the tireless efforts of our road crew in maintaining our roadways and ensuring their safety and accessibility, particularly during challenging weather conditions. We express our sincere appreciation to the fire department for their unwavering commitment to community safety and their active participation in various town events throughout the year. We extend our gratitude to all town committees for their volunteer service. We also acknowledge the significant contributions of the Historical Society, the Meeting House, and the North Chesterville Extension Homemakers in preserving our town's history and organizing numerous community events. We are fortunate to have such a dedicated and committed team serving the citizens of Chesterville. We encourage all residents to consider joining one of the many boards and committees that is dedicated to the continued strength and vitality of our Town.

The Selectboard eagerly anticipates the opportunities that 2025 will bring. We encourage all residents to actively engage in town government by attending our regularly scheduled meetings and sharing concerns with the board. Your input is important in guiding our decision-making processes and ensuring that Chesterville remains a thriving and vibrant community.

TO: Glenda Barker, a resident of the Town of Chesterville, in the County of Franklin, State of Maine,

GREETING: In the name of the State of Maine, you are hereby required to notify and warn the inhabitants of the Town of Chesterville in said County and State, qualified by law to vote in town affairs, to meet at the **Dave Archer Town Office** in the said Town on **Friday, March 14th, 2025 A.D. from 1:00 p.m. until 7:00 p.m.,** then and there to act upon Article 1 and by secret ballot on Article 2 as set out below; And, also, to notify and warn said inhabitants to meet at the **Dave Archer Town Office** in said Town on **Monday, March 17th, 2025 A.D. at 7:00 p.m.,** then and there to act on Articles 3 through 40 as set out below,

Article 1

to wit:

To elect a **Moderator** to preside at said meeting and to vote by written ballot.

Article 2

To elect all necessary **Municipal Officers** as are required to be elected by secret ballot.

Article 3

To see if the Town will vote to permit municipal staff and elected State officials, who are not residents of Chesterville, to speak when recognized by the Moderator.

To see if the Town will vote to authorize the Board of Selectmen to enter into a contract for the Revaluation of all property in Chesterville to begin in 2026 and end in 2027 - and to raise and appropriate from taxation a total of \$50,000 in 2025, and another \$50,000 in 2026 and another \$50,000 in 2027 for a total of \$150,000.

Explanation: The board is currently working to collect information and bids on a town wide revaluation project. More information will be available for discussion at town meeting.

To see if the Town will vote to raise and appropriate from taxation **\$25,000** for **Assessing** and **Maps** and appropriate **\$3,000** from the Undesignated Fund Balance (surplus) for a **total budget of \$28,000** in the current year.

Article 7

To see if the Town will vote to authorize the Select Board to **change the Annual Town Meeting in March from Monday to Saturday.** *Voting would be the preceding Friday* This change will continue in effect until repealed or amended.

Article 8

To see if the Town will vote to appropriate from the Undesignated Fund balance (surplus), **\$9,304.11** to cover all **2024 overdrafts**.

Article 9

To see if the Town will vote to authorize the Select Board to spend an amount not to exceed **3/12 of the annual budget** in each budget category of the 2025 annual budget during the period from January 1st, 2026 until the date of the 2026 Annual Town Meeting.

Article 10

To see if the Town will vote to make **property taxes due on December 12th**, **2025**, and to begin charging **interest** on taxes received on or after **December 13th**, **2025** at a rate of **7.5%** annually.

Article 11

To see if the Town will vote to authorize the Select Board to apply for a **Tax Anticipation Note**, if needed, to pay current expenses and to pay any interest and costs from overlay.

Article 12

To see if the Town will vote to authorize the payment of **tax abatements** approved by the Select Board/Assessors **from overlay**.

Article 13

To see if the Town will vote to set the **interest rate** pursuant to 36 M.R.S.A. § 506-A to be paid by the Town **on taxes paid and later abated at 4% annually** from the date of the tax payment to the date the abated amount is refunded to the taxpayer.

Explanation: If taxes are paid but later abated, the municipality must refund the abated taxes and pay interest on them. For taxes paid on or after April 1st 1996, 36 M.R.S.A. § 506-A provides that the rate of interest set by the municipality to be paid on overpayments may not exceed the rate set for the delinquent taxes, nor be less than that rate reduced by 4%. For instance, if the delinquency rate is 8%, then the Town Meeting may not set a rate lower than 4%.

Article 14

To see if the Town in accordance with 36 M.R.S.A. § 506 will vote to authorize the Tax Collector and Treasurer to accept **prepayment of taxes** not yet committed and to **pay no interest thereon**.

Article 15

To see if the Town will vote to authorize the Select Board, on behalf of the Town, to sell and dispose of any real-estate acquired by the Town for nonpayment of taxes thereon, on such terms as they deem advisable; and to execute the appropriate deeds for such property. Except that the Select Board shall use the special sale process required by 36 M.R.S. § 943-C for qualifying homestead property if they choose to sell it to anyone other than the former owner(s).

Article 16

To see if the Town will vote to apply available excise taxes (vehicle and boat), tax interest, miscellaneous revenue, and lien charges to lower the commitment.

Explanation: Figures for this Article and Article 17 are determined by our Assessor and Treasurer at the time of commitment and are based on actual revenues received by the Town in the current year.

Article 17

To see if the Town will vote to accept the following gifts, grants and funds listed below as provided by the Maine State Legislature, and any other sources and apply the funds to lower the commitment or benefit the town in such other ways as the Select Board deems reasonable.

From the Treasurer's Pesk

Greetings!

As we move into the new year, I wanted to provide an update on the Town's financial status and upcoming budget considerations. I'm proud of the work done by department heads and the board to cut costs in every possible way. In December, we began to prepare for town meeting and set budgets for 2025. There are some significant cost increases but overall 2025 municipal taxation should look very similar to 2024. We reduced budget costs in all available areas to assist with the unavoidable increases of others.

You'll see an article on this year's warrant to start the process of a town-wide revaluation. This is an extremely important next step to getting our real estate values closer to fair market value so that we can certify our tax commitment at 100%. Revals are typically done every ten years but because of the COVID-19 pandemic, and inflated prices in the real estate market, many Maine towns jumped in line to get revals done. By flooding the limited market with requests, many towns are having to wait two to three years to get it done. We hope to move forward with O'Donnell and Associates beginning this spring. It's very important to have equitable values so that property taxes are fair. Expect valuations to increase closer to sales in our area, but don't be alarmed. That doesn't mean your taxes will go up. The mil rate will decrease as property values get closer to market values. Our largest expenditures continue to be the Public Works Department and Capital Roads. These combined budgets represent our annual investment in road maintenance and improvements. We anticipate receiving FEMA reimbursements for damages caused by winter storm Elliot (2022), the May first storm, and the June storm (2023). These funds, while already spent on repairs using taxpayer dollars from the regular budget, will be re-applied to support the Public Works and Capital Roads budgets in the current year. Clayton Tibbetts and Christine Stevens worked with the folks from FEMA to determine funds expended prior and collect all the data needed for reporting. We received the first installment in late 2024 and hope to have the second round of expected funds in the coming months.

The American Rescue Act Funds were fully expended as of December 31st, 2024! The Town of Chesterville really stretched the two tranches totaling \$142,746.98 to cover many useful upgrades in town. Its nice to finally close that chapter.

On a personal note, I took advantage of a few refresher training opportunities last year and am excited to continue learning and growing in my role in 2025. My position and the level of responsibility have increased exponentially since I began serving as your Treasurer, and I am dedicated to staying up-to-date on best practices in municipal finance.

Finally, I want to express my sincere gratitude to the residents of Chesterville for your continued support. I also want to thank Missy, Katlin, Christine, Anne Lambert, the Select Board, and all the other town employees for their hard work, collaboration, and dedication to the residents of Chesterville. It is a privilege to work alongside all of them.







Animal Control

Hello Chesterville, I have been an Animal Control Officer for ten years, and things have certainly changed in that time. The biggest issue I face is the stray cat population and what can be done about it. Historically they were brought to the Franklin County Animal Shelter, but because of limited space available they are often at capacity and not accepting intakes. Donations for increased room is less effective. I recommend making a donation toward a spay/neuter movement. This will help to slow population growth, especially in strays. Please don't feed any cat that isn't yours. This will encourage them to hang around.

There is no leash law for cats. In general, when left alone and not fed, they will move on or go home. If you feel that you must feed a stray, then consider trapping to have it spayed or neutered. If you have a cat that is allowed outdoors, I strongly encourage you to have it spayed or neutered and microchipped. There are several programs available locally to do both of these for free or for as little as \$10! A chip for tracking will make your pet easy to identify. At the very least, a tag or label on its collar will save you the expense of finding your stray dog at the Animal Shelter.

If you own dogs they must be kept on your property. There are lots of options to ensure limited roaming, including panel or chain link fencing, a radio fence, runner or something similar.

Dogs can be licensed for the following year starting in mid-October. A hefty late fee of \$25 is automatically applied after January 31st, except for new dogs.

Thank you for entrusting me with this important responsibility. It's not always easy, and poses some challenges, but is rewarding. Thank you for your continued support.

We approved 1 subdivision application and 3 shoreline zone applications in 2024.

This year we have been busy bringing back the site plan review ordinance. A lot of residents expressed concern with the idea of big businesses coming into town and asked that the planning board revisit the site plan review ordinance for a town vote. We hosted a public workshop in December 2024, and held a public hearing in January 2025. We had some great input and suggestions from residents and made minor changes to the previously submitted site plan review. ASSESSING AGENT REPORT

It has been a pleasure to continue work on the tax assessments in Chesterville. Sale prices of real estate in Maine, including Chesterville, have been increasing at a pace that is unprecedented. As a result, in order to stay compliant with state assessment standards and to maintain individual exemptions, like the homestead and veteran's exemption, at the full amount, we had to increase property valuations this year.

This year the tax rate was \$13.05 per thousand dollars of value. The Town had 7 new homes valued at \$1,247,800. 402 properties qualified for the Homestead exemption. The total taxable valuation of the Town was \$164,661,800. \$2,148,836.49 had to be raised from taxes for the Town, school district and county.

Taxpayers are reminded that the State of Maine has three partial exemption programs for certain individuals. A homestead exemption of \$25,000 in valuation is available to residents in their primary home. A veteran's exemption of \$6,000 is available to certain war time veteran's or veteran's widows upon reaching the age of 62 or totally disabled veterans. There is a blind exemption of \$4,000. There is also a renewable power exemption for owners who install solar or wind power equipment on their property.

There is no requirement to re-apply if you are already receiving one of these exemptions. It is a good idea to inform the office if you are moving from one house to another in Town. First time applications need to be filed with the Town by April first.

BUDGET COMMITTEE

To the Citizens and Taxpayers of Chesterville,

Budget Committee members attended Select Board meetings during the department heads presentations of their 2025 budget requests, and also discussions of those requests by the Select board. We held a separate 2 ½ hour meeting to discuss our recommendations to the Legislative Body.

In comparing last years' actual expenditures with 2025 department requests, we came up with our recommendations. We took into account increasing costs and the impact that an increased budget would have on taxes, while still providing necessary services to the town at a sustainable level. The majority of budgets decreased from 2024.

Only 3 budget recommendations differ from the board: Administration, Transfer Station and Public Works. The differences are in payroll and associated expense lines for FICA/Medicare taxes, IRA contribution at 3%, and Maine Paid Family and Medical leave at .05%, (a new expenditure this year mandated by the State).

The proposed Transfer/Recycling Budget has increased \$31,096.86 over actual expenditures of \$159,451.14 in 2024. Due to increased tonnage and disposal fees, we paid \$8,570.77 more than was budgeted for in 2024. In 2024 the town disposed of 797.35 tons of curbside trash and demolition debris, an increase of 43.46 tons from 2023. Until June, disposal fees per ton are \$101.13 for demolition and \$98.13 for curbside through Waste Management. Beginning in June, through our new trash collector Casella's, the fee will be reduced to \$86 per ton for both types of waste. Recycling by more citizens would help to reduce those costs even more.

Improving our road infrastructure is an extremely expensive undertaking. We think Capital Roads is a worthwhile expenditure. \$386.175 is recommended this year as follows: \$48,672 LRAP, \$31,074.18 FEMA, and \$306,428.82 in taxation. Last year's taxation amount was \$327,519.31. A stipulation for part of the FEMA reimbursement requires two roads be done by July 2025. The town anticipates receiving future FEMA reimbursements, unfortunately, that amount was not known in time for budget preparation. When FEMA money is actually received, more roadwork not currently proposed in this budget could be done.

We recommend raising \$50,000 this year, and \$50,000 each year, for the next 2 years for a town wide revaluation so it could be completed in 2027. The projected total cost is \$150,000. A revaluation adjusts property assessments to reflect market value and ensures a fair distribution of the tax burden for all property owners.

The final vote for expenditures will be decided by registered voters at Town Meeting on Monday, March 17,2025. Please attend and voice your opinion, for or against the recommended amounts.

Peer Support Team. Working with the International Critical Incident Stress Foundation (ICISF), all members of the team were trained and certified in Critical Incident Stress Management (CISM) in April of 2023.

The Franklin County Peer Support Team provides several services for First Responders in Franklin County. These first responders include fire, EMS, corrections and patrol personnel. Primarily, members are resources for their agencies and those surrounding them. Members organize and facilitate Critical Incident Stress Management Debriefings when requested. In 2024, members organized and facilitated 7 Debriefings with over 90 participants. Members also conduct one on one check ins when a referral for a First Responder was received. Members organized and facilitated dozens of one-on-one check ins.

The Franklin County Peer Support Team has continued to add members to the team and get them CISM trained. The FCPST meets monthly to discuss various topics, trends, and continue on-going training to keep skills fresh. This allows the team to be ready to respond at any time. In September, the area hosted its annual Wellness and Resiliency Seminar at UMF which was widely attended by over 90 First Responders locally and from away.

In closing, I want to thank all of you for the support that you have provided to the Sheriff's Office over the years. We could not be as successful as we have been without you as our partner. To our friends in Chesterville.

The Sheriff's Office answered **890** calls for service in Chesterville in 2024, which is 3 calls higher than the previous year. In 2023 we covered **887** calls for service.

Whether or not calls for service increase or remain stable, we have seen an increased demand for patrol to assist towns who may have police departments that find it difficult to fill vital patrol slots. The Sheriff's Office Patrol Division remains a force multiplier to assist those towns. We have either covered calls full-time in some towns or assisted in filling a patrol gap when needed. We will always do our best to support our patrol friends and peers in all towns within the county.

Because of these increased needs, we have had to find innovative ways to add additional staff through grants or the state Unorganized Township funds to fill our own gaps in coverage. We have also added an additional sergeant's position to our supervisory staff to help oversee patrol operations day.

We continue to see an increase in people who are drug addicted or suffer from mental health issues. Whenever a deputy runs into this type of contact it can easily take him off the road for hours if not for the rest of the patrol shift while he guides the person in crisis through the process of seeking the help they need for their addiction or mental health issues.

Where do people go after they have had contact with law enforcement and have been arrested? Well, they go to the county jail. Our dedicated staff of Corrections Officers work hard within the walls of the jail to also help guide people who arrive angry and/or addicted.

In order to help combat these issues within our community, the Sheriff's Office through the leadership of Franklin County S.O. Sergeant Ryan Close and Director LeeAnna Lavoie of the Healthy Community Coalition of Franklin County applied for and received a Bureau of Justice Assistance grant called COSSUP. This stands for "Comprehensive Opioid, Stimulant and Substance Use Program". This grant will enable the Sheriff's Office Jail staff to comprehensively address the impact of illicit opioids, stimulants, and other substances through a vetted model approach which has proven results in other jails within Maine. This model, once fully implemented, will work to prevent and reduce drug overdose incidents and death, as well as reduce jail recidivism rates.

Not only have we been working on behalf of people that encounter law enforcement, but we have also been concerned with the mental health of our local first responders within Franklin County. In March of 2023, several public safety agencies within Franklin County banded together to create the County's first Public Safety

Throughout my travels around the state, I heard many concerns about the cost of living and affordability of housing. Many of you also shared your concerns about access to medical and mental health services. The *Inflation Reduction Act* has been incredible for older people in Maine – Medicare is finally negotiating lower prices for prescription drugs, on top of the \$35 per month cap for insulin that took effect in 2023. We have an opportunity to build on what we have in common and do what Maine people do best; we will continue to help each other and lead through example.

I have also been consistently working to help our veterans. My team has repeatedly been successful in securing long-overdue recognition of military medals for many of Maine's combat veterans and working to resolve issues with claims, travel pay, and access to healthcare and benefits our veterans earned through their selfless service to our country. I have also worked with my Veterans Affairs and Defense partners in Washington to successfully pass a national defense bill that strengthens our national security, takes care of our service members, and supports Maine businesses from Aroostook to York County.

I am also thankful to have such an incredible team across Maine available to you for hurdles you may face with the federal government. Whether it be veteran issues, social security problems, student loans, immigration, IRS and more, please never hesitate to reach out to my offices in Presque Isle, Bangor, Augusta, Portland, or Biddeford and allow us the chance to be part of your solutions.

Together, over the next six years, I know we can continue to build a stronger, brighter future for our great state. Thank you for being one of the reasons Maine is so special; it is not only a pleasure to serve you — it is a pleasure to know you. Mary and I wish you a happy and safe 2025.

Dear Friends:

It is an honor to represent Maine in the United States Senate, and I welcome this opportunity to share several key accomplishments for our state from the previous year.

As Vice Chair of the Appropriations Committee in 2024, I have secured nearly \$580 million for 230 projects across all of Maine's 16 counties to promote job creation, workforce training, and economic development; expand access to health care; support law enforcement; improve public education and infrastructure; and protect our environment. As the new Congress begins, I am honored to be taking the helm of the Committee, the first Mainer to do so in nearly a century, and I remain committed to ensuring that federal spending produces real results for our state and nation.

Maine has the oldest average age in the country, which is why I have long prioritized health-focused legislative efforts. There were more than 1,860 health care bills introduced during the 118th Congress. Only 15 health care bills were signed into law, and I was a lead sponsor of five of them. These bills will enhance care for individuals with Alzheimer's, autism, and substance abuse issues through improved research funding, strengthened public health programs, and increased support for rural first responders.

Another important bill that I coauthored was the *Social Security Fairness Act*. Since 2003, when I led the first-ever Senate hearing on the Windfall Elimination Provision and the Government Pension Offset, I have sought to end these provisions of the *Social Security Act* that unfairly reduce the Social Security benefits that public employees or their spouses have earned. I am pleased to say that with the passage of my bill, the *Social Security Fairness Act*, in December, public sector retirees will now receive the full Social Security benefits they have earned.

When the Maine way of life was under threat, I was certain to defend the interests of our state. I worked to protect Maine's potato farmers when the Department of Agriculture tried to reclassify the potato from a vegetable to a grain. I thwarted efforts to consolidate USPS mail operations at the Hampden postal facility, which would have disrupted mail delivery throughout our state. I sounded the alarm with leaders at the FBI and Departments of State and Treasury on the spate of illicit marijuana growing operations that are destroying properties and providing refuge to foreign criminals in our state. Following damage to our working waterfronts after last winter's storms, I secured \$15 million to help fishing communities recover. I championed funding to support the Maine Air National Guard base, Bath Iron Works, and Portsmouth Naval Shipyard.

As of last December, I have cast more than 9,100 consecutive votes, continuing my record of never missing a roll-call vote since my Senate service began in 1997. My ranking as the most bipartisan Senator reflects Maine's tradition of working with a spirit of cooperation and respect.

Dear Friends,

I hope this letter finds you well. It's an honor to continue serving as your representative in Congress, and I take the responsibility very seriously. Thank you for the opportunity to share an update on the work I've been doing for the people of the Second Congressional District.

Fisheries: This spring, the Atlantic States Marine Fisheries Commission (ASMFC) announced a gauge increase for lobsters caught in the Gulf of Maine beginning in January 2025. Maine fishermen warned that this decision is founded on incomplete and inaccurate data. Additionally, this gauge increase could put Mainers at a competitive disadvantage to Canadian fishermen with looser regulations. That's why I sent a <u>letter</u> to the ASMFC urging them to delay their decision until they can evaluate data with fishermen, whose proactive stewardship provides invaluable insight. I have also submitted an amendment to this year's funding bill that would block federal funding from being used to implement and enforce a gauge increase. Because of these efforts, the ASFMC made the decision to delay the implementation of this new requirement. I'll always stand with Maine lobstermen against unfair, unnecessary regulations that threaten their livelihoods and industry.

Veterans: The first meeting I attended as an elected official was with a large group of veterans and the former Director of the Maine Bureau of Veterans Services. We discussed a lot, but one issue rose above the rest: how little was being done for Maine veterans who needed treatment for mental health issues or substance use. At the time, there were no in-patient treatment beds in Maine, so veterans had to wait for a bed to open up at an out-of-state facility. Fast forward 10 years, through unending red tape, and I'm delighted to report we just broke ground on a treatment facility at the Togus VA Medical Center in Augusta. This was the direct result of the tireless advocacy of veterans from across our state — this win is theirs.

Postal Service: This spring, the U.S. Postal Service (USPS) announced plans to consolidate and move some processing operations from the Eastern Maine Processing & Distribution Center in Hampden to Scarborough. This would have caused significant mail delivery delays that disproportionately harm rural communities. That's why I introduced the *Timely Mail Delivery and Postal Services Protection Act*, which would have halted this planned consolidation across

Following these efforts, the USPS announced they have scrapped their plan entirely. While this is a win for Maine, it is also evidence that we cannot become complacent. That's why I recently introduced the bipartisan *Postmaster General Reform Act*, which would establish term limits for the United States Postal Service's (USPS) postmaster general and require nominations to be confirmed by the Senate.

Regardless of the year, one of my top priorities is ensuring I'm accessible to you. My staff and I can help navigate federal programs; find resources in Maine; and resolve issues with Medicare, Social Security, the VA, and other federal agencies and programs. We are here to help:


